



Admission to Pre-School (Stage 1) and Primary School: End of Procedure Guidance for Parents

An email will be issued to parents on Thursday, 27 April 2023 advising them of the outcome of their child's application (excludes pre-school underage and late deferral applications).

This short visual guide sets out the steps for parents to log in to EA Connect (where they can also view the outcome of their child's application) to:

- 1. Accept (or Reject) a place offered; or
- 2. <u>Add Additional Preferences</u> for consideration for a child who has not been selected for admission to any pre-school/school listed on their initial application.

Please note that parents <u>cannot</u> complete a change of preference nor appeal the decision of a school's Board of Governors not to admit their child, in the EA Connect portal. Separate guidance will be available on the <u>Education Authority website</u> from 27 April 2023 on these processes.
